PROPOSED DEVELOPMENT:

Request for Amendment to Coastal Development Permit to modify Special Condition #1 (Timing of Operations). The Applicant proposes that major project operations, including veg. eradication/removal, and hauling be prohibited from 3/15 to 8/1, with exception of small spot removal events. The proposed Amendment would allow tarps to solarize iceplant for 3 months versus 2, providing a higher percentage of desiccation.
