



REQUEST FOR PROPOSAL (RFP) COMEDIAN GUEST SPEAKER

The Bay Foundation (TBF) seeks a qualified comedian as a contractor to participate in two virtual clean boating presentations as a guest speaker.

Background

The Bay Foundation is a 501(c)(3) nonprofit organization, Federal Tax ID# 330420271. TBF's [Boater Education Program](#) creates and distributes tools and resources to educate the boating community about environmental boating laws, proper waste disposal, and pollution prevention practices. The Boater Education Program focuses on boat-based pollutants including sewage, oil, fuel, household hazardous waste, marine debris, and aquatic invasive species.

The purpose of contracting a comedian as a guest speaker is to utilize their comedic skills to connect to the boating community audience on an emotional level. Comedy makes [knowledge easier to recall](#) and will hopefully lead to increased environmental awareness and behavior change. This project is grant-funded by the Clean Vessel Act Education and Outreach Grant Program. California State Parks Division of Boating and Waterways (DBW) must review and approve the script and may request edits. The selected contractor will develop a script while following these guidelines:

- No vulgar or derogatory language directed at the government (local, state, or federal)
- No profanity or offensive language
- No unapproved improvisation

The virtual clean boating presentation will take place via [Zoom](#) and may occur on nights and weekends. TBF will work with the selected contractor to schedule the presentations.

Scope of Work

- Develop material and prepare one script for a 5 minute sketch. The material should include the topic of sewage in some capacity.
- Submit the script to TBF for review.
- Make any requested changes or edits to the script.
- Conduct two live virtual sketches and be available for a max of 30 minutes on presentation days for logistics.



The virtual clean boating presentations will be recorded. The recorded presentations and material could be used for further engagement through social media, presentations, and other TBF digital and/or print education and outreach efforts.
